
AMENDMENT/ CASE/LAW	YEAR	EXPLANATION/RULING/RESULT
13 <sup>th</sup> Amendment	1865	Abolishes Slavery
14 <sup>th</sup> Amendment (Equal Protection Clause)	1868	Specifies that no state shall deprive any person of life, liberty, or property without due process of law. It also prohibits states from denying any person equal protection under the law.
Brown v. Board of Education	1954	Held that a state's public schools must be "separate but equal".
Civil Rights Act	1964	Prohibits discrimination in public accommodations, employment, and voter registration.
Seminole Tribe of Indians v. Florida	1971	Established the doctrine of "state sovereign immunity" by holding that tribal nations are not subject to the jurisdiction of state courts.
Rights of the Child Act	1973	Established the right of children to receive a free, quality education.


